Requested that the decision be looked at again.

Serena (SLE, CNB) – agrees with sentiments from Kong. Feedback from parent community states the same sentiments as well.

Moyra Baxter – Agrees with the statements, and explained that all items were agonized over before a decision was made. The district is very aware of the challenges this decision has made. However there was no land available to build a new secondary school, therefore this difficult decision was made because there was space to make changes within the Elementary school level. The city of West Kelowna has no land they wish to sell. Actively looking for solutions for any problems this has created.
